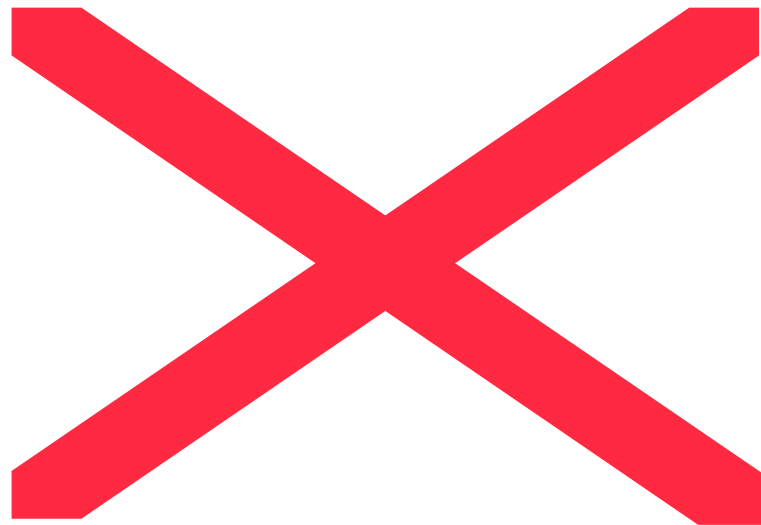

# Voting on Priorities for Analysis

- Each PWG member received a ballot via email
- Each respondent cast 10 votes, with no more than one vote per option
- 18 PWG members responded out of 20 (best response rate of all PWGs...but who's counting?)
- CCS compiled results to be distributed to the PWG members

# Balloting Results – Tier I

- RCI-1A: “Expanded DSM”
  - 18/18 votes (100%)
  - Includes Utility DSM, Muni and Coop DSM, and Energy Portfolio Standards
  - Also 9.2, focus on existing market segments (?)

# Balloting Results – Tier II

- RCI-1B: “Funding for EE” (15/18 = 83%)
  - Energy Efficiency Funds, Audits, Financing
- RCI-3C “Resources & funding for Building Efficiency” (15/18 = 83%)
  - Promotion & incentives of improved design
  - Training of builders/contractors, operators
  - Feebates
- RCI-3D “Existing Structure Retrofit” (14/18=78%)
  - Recommissioning, tracking & benchmarking
  - “Incentives” and “statewide effort”
- RCI-3A “Building Codes & Enforcement” (13/18=72%)
  - Stronger codes & enforcement
  - Includes rules on cement, minimum requirements on new & remodeled homes

# Balloting Results – Tier III

- RCI-5A: “Pricing and Purchasing” (10/18 = 56%)
  - Green power & bulk purchasing programs
  - Net metering, TOU, and/or tiered rates
  - Price-responsive demand, in-home energy displays
- RCI-6A “Passive Solar” (10/18 = 56%)
  - Promotion & incentives
  - Passive solar heating & hot water
  - passive cooling design including white roofs, landscaping
- RCI-6B “Energy Delivery” (9/18 = 50%)
  - CHP, customer-side transformers

# Balloting Results – Tier III (cont'd)

- RCI-3B: “Planning and Design” (8/18 = 44%)
  - Improved community planning, “smart growth”
- RCI-8B “Industry-specific programs” (8/18 = 44%)
  - Industry-specific cap & trade
  - Small-source aggregation
  - Focus on SMEs
  - Industrial Ecology / by-product synergy

# Just missed the Cut...

- Tied at 7/18 votes (39%)
  - Regional market transformation alliance
  - Education & Outreach
  - Voluntary public/private partnerships
  - EE & RE requirements for government agencies
- 6/18 votes (33%)
  - Improved building practices
  - Funding options for businesses
- 5/18 votes (28%)
  - State-level appliance standards
  - Residential Energy Conservation Ordinance

# Less popular...

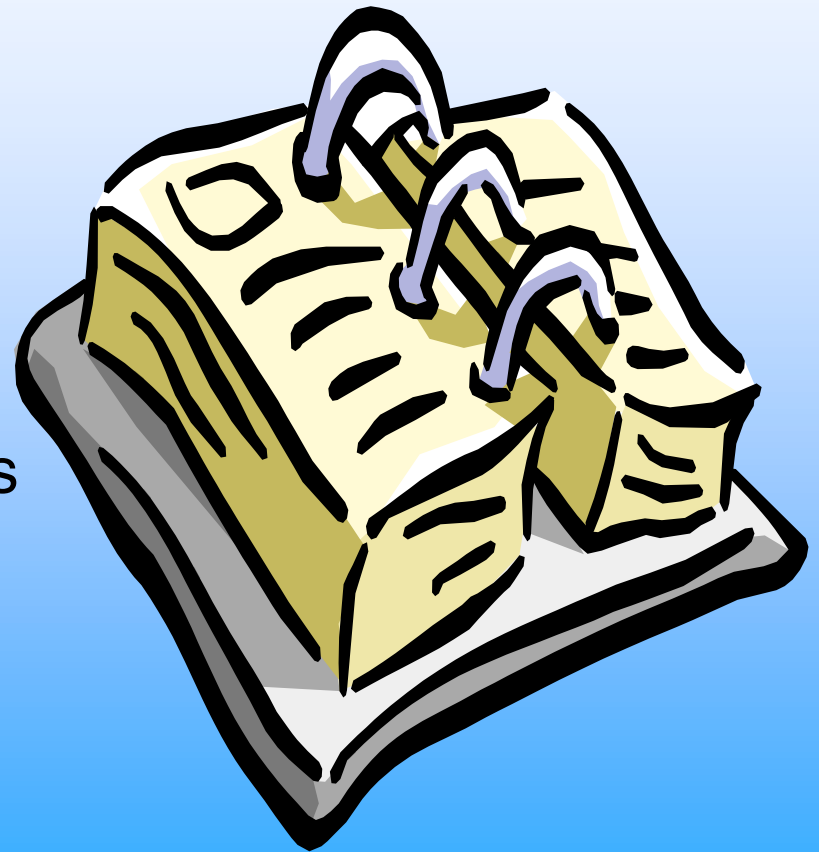
- Tied at 4/18 votes (22%)
  - Support for stronger federal appliance standards
  - Support for industrial fuel switching
- Targeting appliances - 2/18 votes (11%)
- Substitution of non-GHGs - 1/18 votes (6%)
- Industrial process improvements – 0 votes

# Inventory and Forecast of Colorado GHG Emissions

- Preliminary analysis for further discussion and revision
  - Inventory of historical emissions from 1990 to most recent data year
  - Projection of emissions to 2020
- Prepared by CCS for Colorado Department of Public Health & Environment (CDPHE) under contract to the Western Regional Air Partnership (WRAP)
